Spectra Energy Corp, a Fortune 500 company, is one of North America's leading pipeline and midstream companies. For nearly a century, Spectra Energy and its predecessor companies have developed critically important pipelines and related infrastructure connecting supply sources to premium markets. The company's operations in the United States and Canada include more than 22,000 miles of natural gas, natural gas liquids, and crude oil pipelines; approximately 305 billion cubic feet of natural gas storage; and 4.8 million barrels of crude oil storage.

Multiple teams at Spectra Energy are involved in maintaining the company's various Hyperion EPM applications. A lack of metadata governance was causing several issues; the teams were unable to maintain historical hierarchies, view and validate hierarchical changes, or provide sufficient audit trails for changes and approvals. Spectra was using manual steps to insert, remove, or modify any Hyperion "node" across multiple applications and databases. Though these steps can be simple, they can also be time consuming and tedious — which inevitably led to human error.





Spectra Energy needed a strategy for success and a roadmap to get them there. US-Analytics applied our proven methodology for recommending and prioritizing next steps: Vision, Readiness, and Mobilization (VRM). By working with Spectra Energy's functional, technical, and executive stakeholders to define their vision for effective EPM, we ensured smooth change management and gained a full understanding of their pain points — then recommended the most appropriate solutions and next steps.

To prioritize recommendations, US-Analytics gauged the effort, value, and impact of each project. Spectra's solution began with the highest impact and highest value project: implementing Oracle Data Relationship Management (DRM).
